Multi-year rate plan approved

On November 2, 2015, Xcel Energy filed an application with the Minnesota Public Utilities Commission (MPUC) for a three-year, \$297.1 million, or about 9.8 percent increase in electricity rates. This proposal included a rate plan to provide customers with more predictability and rate stability for a longer period of time than under a single-year rate request. On June 12, 2017, the MPUC approved a Settlement Agreement that established a rate increase of \$244.7 million or about 8.28 percent spread across four years.

There is no increase to 2018 rates, and we will provide notice with the 2019 increase. The current monthly customer charge remains the same with no change for 2016 through 2019.

Revenue decoupling pilot program in effect January 2016 through 2019

The pilot program allows Xcel Energy to adjust its rates up or down for residential and small business customers once a year to make up for any shortfall or excess in non-fuel revenue.

The pilot program began with January 2016 usage. The first decoupling surcharge or credit will appear as a line item on customer bills effective October 1, 2017. How the changes affect your individual monthly bill will vary depending on the amount of electricity you use. Your monthly bill will also vary due to changes in the cost of fuel Xcel Energy purchases to generate electricity for your use. Please remember that the amount you are charged for fuel cost is the same amount Xcel Energy pays.

There are no changes in the monthly customer charges through the end of 2019 except for the Commercial and Industrial General categories, which are slightly changed.

Refund

State law allowed Xcel Energy to collect an interim (temporary) rate increase while the MPUC considered the rate request. The interim increase of \$163.7 million annually for 2016 and 2017 or 5.5 percent began on January 1, 2016 and continued through September 30, 2017. The final rate increase for 2016 is less than the interim rate amount collected in 2016. However, the final rate increase for 2017 was more than the interim rate amount collected in 2017. The 2016 over-collection with interest will be applied to the 2017 under-collected amount. Residential customers will receive an estimated refund, with interest, of 3.42 percent which includes the interim refund, a small credit resulting from the true-up of 2016 capital projects due to the timing of project completion, and our use of a deferred tax asset. A typical residential customer's refund will be about \$3.33, which will appear on October/November bills.

Residential customers will see a 2017 level increase in the base energy charge per kWh from 9.395¢ to 10.582¢ during summer months and from 8.040¢ to 9.032¢ during other months (without electric space heating). The net impact of these changes is an average 8.0 percent overall bill increase for residential customers. Under the MPUC approval, electric rates increased for all customer classes listed on the inside of this notice.
